



Market Report

2020 Week 37

Finished pig prices have lost small amount again this week the EU spec SPP fell by 0.34p on the week to average 1.6238p/kg, this is around 9p higher than last year at this time but the gap is narrowing, slaughtering at British abattoirs totalled 169,500 head during the week about 7500k pigs lower than the week before. A large number of pigs had to be rolled last week due to factory breakdowns and processors could not deal with the numbers coming forward.

This week however we have seen less pigs rolled than in the previous week and the situation if we carry on is manageable. All major processors have stood on with their weekly pricing elements and contractual arrangements which might be the first sign of things to come.

On the fresh meat market demand from the high street was reported as ok and one or two of the smaller abattoirs did report that they were tidy with pig numbers, sales were hard but all reported an upswing in their beef through put.

Sow prices again this week have stood on which is a good indicator that the German marketplace has turned back to normal in its demand for product.

However the store pig and weaner markets are over done with pigs at the moment with a lack of finisher space been at a premium for some finishers to take these pigs on board.
