



# Market Report

## 2022 Week 17

The SPP continues to rise, the EU spec SPP has risen this week by 4.1p to stand this week at 161.74p/kg, obviously this is a lot less than last weeks 7p increase. Estimated slaughtering's were 183,300k head, 9% lower than the previous weeks full kill but remember it was a short week with Easter and certain plants were broken down, carcass weights averaged out at 93.14kg which is still heavier than the same time last year. We still have a back log of pigs and with one major processor it is taking some time to get through the pigs.

We have seen all the major processors bar one stand on this week, and it is feared the SPP may run out of steam, we need the major retailers to come to the table and support the pig industry now! Sows have stood on this week. Fresh meat demand is only steady, but money has gone into the fresh meat plants this week but again they are still competing with cheaper foreign import.
